Our AfA project officer agreed to not hiring a minibus but using the budget line to hire a sound system (£350) and a digital projector (£100) for keynote presentations. We have also added one extra session @ £150 for an artist worker onto the sessional budget, raising that to £1,650, thereby applying the slight underspends in some of the other budget lines. The conference budget balances. Overall we received £6,950 from AfA, £3,034 from the Oak Foundation (trust officer's discretionary grant) and £1,742 from 153 ticket sales at prices from £5 on the keynote Saturday (the only ticketed day). The AfA funding was overspent by £29.09. This is covered by ticket sales and the Oak grant, leaving a net £264.38 towards CHE's overhead/audit costs.

Part two: What the grant has achieved

2 a) Tell us about the difference your project has made to the people that were involved in it.

Typical comments: "I found the lectures filled with passion and hope"; "I am still coming down off the Kandinsky conference [and] I don't think I will ever be the same again." People said they'd been blown away ... first by the Chief Medical Officer's keynote on evidence that meaningful relationships stimulate good health, and art's part in this. That was part of 7 talks on Kandinsky's art, Russian spirituality, community empowerment, and Glasgow Council's arts policy for Govan. Four local art exhibitions showed in the Pearce Institute, a double series of 6 art classes for 18 people ran from Kinning Park, there were 10 workshops, a ceilidh, an optional Russian liturgy, and 3 local tours including Glasgow museums by foot & ferry from Govan.

2 b) Tell us about any wider benefits to the community.

Article about conference in Saturday's Guardian newspaper. 8 mins on prime time Sunday morning BBC Radio Scotland. 20 mins on Glasgow University's Subcity Radio. A 1 hour programme made by Sunny Govan Radio examining arts/health/spiritual questions raised by the conference, including interviews with Sir Harry Burns (the CMO) and local arts visionaries (to be broadcast several times in early Nov). Over lunch on 31st Oct, Plantation Productions convened meeting of 11 local arts figures to discuss "Where now after Kandinsky in Govan?" There was a unanimous feeling that the conference has opened a window on Govan's arts and wellbeing scene, and that we need to act on Harry Burns' advice to develop shared inspirational vision.
